GENERAL TERMS AND CONDITIONS OF USE FOR
FARMERS/CONSUMERS/BUYERS OF PRODUCTS:-

DEFINITIONS:

1. Definitions:

1.1 The Company : WORLDWIDE PEASANT CARE & DEVELOPMENT PRIVATE LIMITED and its unit including Hallo9X.

1.2 The Company Rules: The rules and regulations of the Company, as amended from time to time. A copy of the Company rules will be supplied to you with your Application for Subscription and further copies will be made available on request.

1.3 Commitment Period: The minimum term you are committing to remain a Subscriber of the Subscription being provided by the Company from the Start Date of to the commitment period end date of the period. (subject to conditions).

2. Subscription:

2.1 By signing this Subscription Application Form the Farmer/Consumer/Buyer agrees to comply with these Terms and Conditions of Company and the Company Rules.

2.2 You will only be permitted to use the Company's equipment provided your subscription is current and fully paid up or you have made payment arrangements acceptable to the Company.

2.3 The cost of the fuel of the equipment/tractors on hire will have to be borne by the Consumer/farmer.

2.4 As a Subscriber you are entitled Post harvest sales Support by the Company.

2.5 The Subscriber/farmer is entitled to logistics service and storage facilities being provided by the Company subject to the approval of the Company.

3. Subscription Categories:

The Company offers different categories of subscription which are set out in the Company's information sheet. Your choice of category on joining will determine the fees you pay and any restrictions that may apply to your use of Company facilities. You may change to any other available subscription category by giving one month's notice to the Company.

The farmers/subscribers can opt-in for a subscription either annually or quarterly and will have to specify the same.

4. Duration:

- (a) When you avail the subscription of services you are agreeing to remain a Subscriber for the Commitment Period.**
- (b). If you choose to join the Subscription Fee by paying your Commitment period subscription fee in advance, your subscription will terminate automatically on expiry of the Commitment Period.**
- (c). In case the Farmer/Consumer agrees to avail the irrigation Infrastructure Facilities of the Company, the minimum subscription shall be for a period of 2 years.**

5. Fees and charges

The Company will set the level of fees/charges and will review such amount periodically. The Company reserves the right to change the level of fees/charges from time to time, but guarantees that your subscription fees will not increase during your Commitment Period. For any changes to the monthly fee, we will give you at least 15 days written notice. The following fees/charges prevail:

5.1 Fees; All other fees and prices for the sale of goods and Company will be decided by the Company from time to time

5.2 We may charge a reasonable fee of upto 50USD for any of the following: replacing lost subscription cards, removing or adding Associate members, changing subscription category and transferring subscription.

5.3 In case there is any breakdown of the machinery/equipment provided by the Company during the period when it is in the custody of the farmer/buyer/consumer, he shall have to compensate the same to the Company.

6. Termination:

6.1 Termination by the Company We may terminate this agreement in the following circumstances:

- (a) if you commit a serious or repeated breach of this agreement or the Company's rules and the subscription breach, if capable of remedy, is not remedied within 7 days of receipt of a default notice;**
- (b) If any part of your subscription fee remains unpaid 30 days after its due date for payment, or**
- (c) If you provide us with details which you know to be false when applying for subscription and the false declaration would have reasonably affected our decision to grant you subscription.**

If we terminate for any of these reasons, we reserve the right to retain a proportion of the money paid under this agreement, to cover any reasonable costs incurred.

6.2 Termination by you You may terminate this agreement in the following circumstances:

- (a) You can give notice to terminate at any point during the Subscription Period but this cannot end your subscription before the end of the Commitment Period
- (b) Outside the commitment period you may terminate your subscription by giving the Company at least 1 full calendar month's notice, so that your subscription will terminate at the end of the following calendar month after notice was given.
- (c) Annual subscription cannot be terminated or refunded and is non transferable.

7. Access Control:

7.1 On joining the Subscription of the Company we will request for you to provide biometric information in the form of a digital signature of your fingertip.

This information is solely used for access control; it provides a cost effective, secure and non transferable solution to preventing unauthorized access to The Company's services . It reduces our carbon footprint.

7.2 The information is fully encrypted and is securely managed by a third party IT company, it cannot be seen as a picture and cannot be transferred to any other reading device to determine the identity of an individual. Your biometric information is deleted should you or The Company terminate the subscription.

7.3 Should changes in physical characteristics result in the biometric template becoming outdated The Company will request for you to re-enrol your biometric digital signature of your fingertip.

7.4 Should for any reason you object to providing this biometric information you will be required to purchase a proximity card at a cost of.....

10. Company Rules:

10.1 The Company may amend the Company Rules from time to time in order to ensure the health and safety of the farmers/consumers/buyers.

Permanent changes to the Subscription policies of the Company will only be made after at least 30 days notice to Consumers/Farmers/Buyers, except in the case of emergency.

10.2 The Company serves the right to adjust the availability of certain facilities or services for the general maintenance of the equipments and machinery.

11. Restriction of Liability:

11.2 Our liability to compensate you for any loss or damage (in the case of loss or damage other than death or personal injury) is limited to a reasonable amount having regard to such factors as whether the damage was due to a negligent act or omission by us.

11.3 The Company does not accept liability for damage, accident, death, personal injury or other loss sustained by subscribers caused by their own negligence or the negligence of the Contractors.

14. Notices: Notices from you to the Company must be by email toor in writing to the manager at the Company

Notice will not be deemed to have been given until you have received an acknowledgement or receipt from the Club.
